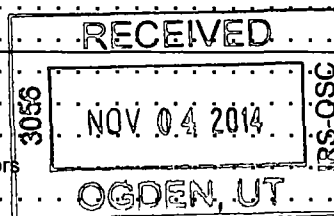

Statement of Organization's Primary Exempt Purpose

The 900 Project, Inc. is an organization operated exclusively for the charitable and educational purposes consistent with IRS Code 501 (c) (3). Presently, its sole purpose is to raise funds to then construct latrines in the village of Tilory, Haiti. Tilory is a village on the eastern side of Haiti where there are roughly 1,000 families currently living there; only 10% of which have their own latrine.

Part of the goal is to provide more sanitary and safer living conditions for the families, which will also curb child deaths and diseases.
