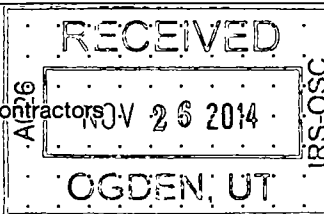

The Chair of the Board of Directors of Aspen Valley Hospital is no longer required to serve as a AVH Director on the Board of Directors of Aspen Valley Hospital Foundation (there are still two AVH Directors required to serve on the Aspen Valley Hospital Foundation's Board). The Executive Committee composition now includes the Vice President, Treasurer and Secretary of the Aspen Valley Hospital Foundation Board which expands the committee from four members to seven.
