Conflict and Development Foundation is interested in promoting natural resource conservation research in southern Africa. Dr. Amanda Stronza in the Department of Recreation Parks and Tourism Sciences at Texas A&M University will lead the "Ecoexist" research effort with local organizations to increase understanding of wildlife and human conflicts in the Okavango Delta of Botswana. Ecoexist seeks to reduce conflict and foster coexistence between elephants and people. In areas of heightened competition for access to water, food, and space, Ecoexist finds and facilitates solutions that work for both species. The Ecoexist model connects science with practice. In collaboration with local communities, Ecoexist will trial and demonstrate a portfolio of tools and strategies that enable people and elephants to coexist.

**4b** (Code ) (Expenses \$ 420,020 including grants of \$ 420,000 ) (Revenue \$ 0 )

Improve quality of coffee plants in South Kivu province of DRCongo through a partnership with the United States Agency for International Development, Catholic Relief Services, and the government of the Democratic Republic of Congo. This project will provide technical guidance to CRS to introduce and field test high performing coffee varieties and lead the development of successful models of small-scale, high-quality coffee production, processing, and marketing relevant to the South Kivu context.

**4c** (Code ) (Expenses \$ 105,044 including grants of \$ 0 ) (Revenue \$ 889,385 )

The Ghana Center for No-Till Conservation Agriculture promotes best agricultural practices in Ghana and throughout Africa to increase food production and on-farm productivity while conserving soil and water resources. This program is accomplished through a variety of research, teaching, and extension activities in partnership between international institutions such as Texas A&M University and local Ghanaian expertise. The Center for No-Till Conservation Agriculture works with Ghanaian universities, Ministry of Agriculture, and other non-governmental organizations to reach farmers and extensionists throughout Africa.

**Explanation:** This was the first full year of accounting for our new non-profit corporation. Consequently, there has been a learning curve with the preparation of financials that directly translate into the form 990. Also, because of the small size of our non-profit, we do not have a full-time dedicated accountant. Therefore, the program staff has been strained to complete research programs and complete filing requirements. To remedy this in the future, we are taking two clear steps. 1) As a result of this year's experience, we have established our QuickBooks accounting system to directly match 990 fields. 2) We have initiated procedures with an accounting firm to audit our books and our 990. This will lead to series of best practices and 990 preparation guidelines.
