The spay neuter program transports animals to a low cost spay and neuter facility in Greensboro NC. At times additional services are required to allow the animal to undergo the surgery. Sometimes the owners cannot pay this additional fee. In the essence of the mission of the organization to get these animals neutered we often pay for these additional services.
