Part 1 Summary: Jacaranda Health is submitting its initial return. Jacaranda Health filed 990N forms for 2011 and 2012 and was under fiscal agent status until the end of 2013. Jacaranda Health received notice of 501(c) 3 status in August 2013. Fiscal agent was FJC, a Foundation of Philanthropic Funds. As a result, there are no reported expenses and only limited revenues for 2013.
