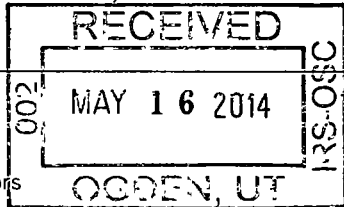

WE RAN SEVERAL OTHER RACES INCLUDING TUNNEL TO TOWERS, USMC MUD RUN, SPARTAN BEAST AND OTHERS.

3. IN DECEMBER, OEW VISITED THE WALTER REED ARMY HOSPITAL TO PROMOTE OUR PROGRAMS AND HAND OUT OVER 100 CHRISTMAS STOCKINGS FULL OF SMALL GIFTS FOR WOUNDED WARRIORS THAT STOPPED BY OUR TABLE. THIS EVENT PROVED TO BE A GREAT WAY TO GET OUR PROGRAMS IN FRONT OF THOSE WE SERVE.
