Explanation: In assessing the requirements for a new organization, much has been learned. This was a one time event due to it being the initial filing. We have established systems and oversight such that all future filings will be made in a timely manner. The organization was in the start-up phase and overwhelmed with making community connections. A late filing penalty would present a significant burden given our limited budget.
