 BMe Community presents black men as assets to society and uplifts their positive narratives Through our narrative shirting efforts, we were able to get national philanthropies and philanthropic associations to consider black men as assets This includes Open Society Foundation, Heinz Endowment, Skillman Foundation, Marguerite Casey Foundation and the Association of Black Foundation Executives We have also won influence with significant media leaders The president and founder of the largest black-owned web media company in the US, Moguldom Media, with a reach of over 6-million viewers per month has agreed to uplift stories of Black male engagement BMe Leader, Chris Norris, is the founder of Techbook Online and a columnist for The Good Men Project which together have a combined reach of over 100-million page views per month has also signed on to the Everyday Stories campaign Our BMe leaders have gotten the attention of local and national media due to their efforts in building their communities The impacts of their work have also been recognized by local, state and federal agencies Another example includes Nasir Al-Maliki, founder of Stop the Violence OPTIONS program, who was instrumental in fostering the Lights On program in Philadelphia Lights On is a national event held among after school programs nationwide to shed light on the importance of after school programs As a result, a proclamation from the Pennsylvania's Governor's office was made proclaiming October 17th national day for after school programs

 BMe engaged people of all race and genders directly in community-building activities BMe has supported over 100 project and community-building events in three cities that ranged from the inaugural annual conference of the International Black Doctoral Network (a network of black Ph Ds and scholars) to rallies to stop violence against women, forums on reintegrating after time in prison, national gatherings of leaders in black male engagement in Detroit & Miami, youth conferences for restorative justice and stopping the school to prison pipeline, pre-screening of influential films such as American Promise, and back-to-school block parties to meet community needs and celebrate community simultaneously A February 2014 survey of BMe Leaders found that their programs have benefited more than 65,000 residents in areas of early childhood development, literacy, school discipline, incarceration, social services, and entrepreneurship and their online and offline events have engaged 60,000 more in 2013 Detroit BMe Leaders have been given the Spirit of Detroit Award by the Detroit City Council in 2013, and BMe Founder, Traban Shorters along with the BMe Leaders in Pennsylvania will be recognized on the floor of the Congress in Pennsylvania this quarter BMe Leader Emmanuel Cephas, Jr, an entrepreneur and software developer, who created a revolutionary math education program called, MIYAGI, or 'Move If You're a Genius Inside' was invited to the White House for recognition as an innovator this year BMe Community in partnership with the John S and James L Knight Foundation and Open Society Foundation hosted our inaugural National Orientation and Training for the 69 BMe Leaders awarded in 2012 by the Knight Foundation and 2013 by BMe Community Awardees were networked and trained on how to build community from an Asset Based approach and learned how to present themselves and their work as assets to society

In 2015 a year after becoming an 501c3 the managing director reached out to the IRS and discovered all of the requirements to file Form 990 and that we had missed the deadline for the 2013 return. Right away the managing director prepared the 2013 and 2014 Form 990, which is being filed today May 8, 2016. No extension of time to file Form 990 was requested because we were not aware of the requirement to file the return. We believe we have reasonable cause for filing late and honestly did not know about the requirement to back file Form 990 for 2013. This was the first time we were required to file this type of return. As soon as we discovered our error, we immediately prepared and are now filing all Form 990s due.
