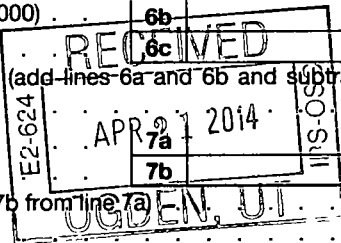



American Heritage Trees purpose is to remember historical sites, people, and events by propagating a living tree from seeds or cuttings of the original tree. American Heritage Trees nursery provides saplings of trees from important places throughout the United States that can be purchased by individuals, schools, or organizations for their yard or garden. Each tree will have a certificate of authenticity and a story describing the historical significance behind each tree.

Before a decision was made to begin American Heritage Trees, careful, systematic market research was conducted to learn more about our intended market. Primary research was done through meetings with other nonprofit organizations, nurserymen, universities, and agricultural extension offices. Paramount to the establishment of American Heritage Trees was meeting with American Forest nonprofit organization.

During discussion and meetings, American Forest approval was obtained to enable the establishment of American Heritage Trees. Additional meetings were held with six nurseries, Tennessee Wilson County Agent, Tennessee Extension Area Specialist, Nursery Crops, Tennessee Forestry Division, Otis Floyd Nursery Research Center, Natural Resources Conservation Service, and Tennessee Urban Forestry Council.

Secondary research was conducted by reviewing published information such as industry profiles, trade journals, and demographic profiles. Most information was obtained from nursery associations, agricultural extension offices, and other nurserymen, as well as universities.

American Heritage Trees has identified and met with both the attorney and tax accountant selected for the organization.

American Heritage Trees has filed the Charter under the Tennessee Nonprofit Corporation Act of the State of Tennessee, adopt the articles of incorporation for such corporation, established Officers, Directors of the organization and adopted By-laws and List of Activities. To date

American Heritage Trees had conducted several meetings with the selected Officers.

American Heritage Trees has identified and contacted 13 nonprofit organizations that are current owners of key historic trees. Currently,

American Heritage Trees has developed and submitted 13 Cooperative Agreements that are under review and consideration of the selected nonprofit organizations.

Income received during 2013 included donations from selected American Heritage Tree officers in an effort to set up the organization. Also, additional financial support was provided by the President and Treasurer of American Heritage Trees. No other income was received during

2013. All expenditures during 2013 were for set up cost, including but not limited to: obtaining the domain name for the organizational website, selecting and approving officers of the organization, preparing required documentation for the business (business plan, by-laws, organizational chart, list of activities, cooperative agreements, conflict of interest policy), attaining and meeting with the organization's

accountant and lawyer. Expense was incurred reviewing the organization's documents with the attorney and making required updates, preparing for filing of the nonprofit documentation both for the IRS and for the State of Tennessee.
