RTH Mission Park Realty Corporation (the "Corporation") was formed on August 20, 2013 under chapter 180 of the General Laws of The Commonwealth of Massachusetts and organized exclusively to benefit, perform the functions of, and carry out the purposes of Roxbury Tenants of Harvard Association, Inc., a Massachusetts charitable corporation ("RTH"). In 2015, the Corporation will acquire from RTH the entire membership interest in Mission Park LLC, a Delaware limited liability company, which is the fee owner of certain real property located in Mission Hill, Boston, MA (the "Project"). The Project consists of an affordable housing project located in Mission Hill, Boston, MA, including residential and related recreational buildings (the "Housing Project"), and a subsurface garage located underneath the Mission Park residential housing and office complex located at 780-850 Huntington Avenue, Boston, MA (the "Garage").1 Mission Park LLC has leased the Housing Project to Mission Park Limited Partnership Name of the organization

(the "Housing Partnership"), a Massachusetts limited partnership controlled by RTH, pursuant to a long-term lease (the "Housing Project Lease"). In addition, Mission Park LLC has

leased the Garage to Mission Park Garage Limited Partnership (the "Garage Partnership"), a Massachusetts limited partnership also controlled by RTH, pursuant to a long-term lease (the "Garage Lease," and, together with the Housing Project Lease, the "Leases"). RTH Mission Park Garage, Inc., a wholly-owned affiliate of RTH, serves as the general partner of the Garage Partnership and RTH is the sole limited partner. In tum, the Garage Partnership separately leases the Garage and use of its premises primarily to The Brigham and Women's Hospital, Inc., a Massachusetts charitable corporation ("B& W"), with a small portion leased to the Housing Pmtnership.

Both the Housing Project and the Garage are operated as urban redevelopment projects subject to Massachusetts General Laws Chapter 121A through July of2015. As Chapter 121A projects, the Housing Project and the Garage are exempt from traditional Massachusetts income, excise and ad valorem real estate taxes, and pay instead certain "Chapter 121A" excises under Sections 6A and 10 of Chapter 121A. This special tax treatment under Chapter 121A is scheduled to expire in 2015.

At the time of the expiration of the projects' "Chapter 121A" designation in 2015, RTH plans to transfer the membership interest in Mission Park LLC to the Corporation so that Mission Park LLC will be wholly-owned by the Corporation. The Corporation will then dissolve Mission Park LLC and the distribution

of its assets, the Corporation will be the fee owner of the Housing Project, the Garage and all other property previously owned by Mission Park LLC. Moreover, the Corporation will become the lessor under the Leases. Concurrently, upon expiration of the projects' "Chapter 121A" status, the Garage Partnership and its general partner will be dissolved and all of their assets and liabilities will be assigned to and assumed by the Corporation. Accordingly, after the dissolution of Mission Park LLC and the Garage Partnership, the Corporation will own fee title to the Garage and will serve as landlord under the leases with B&W and the Housing Partnership, respectively.
