Request for Waiver of Penalties for Late Filing of 2013 Tax Return (Form 990)

Beverley Taylor Sorenson Foundation (Foundation) received its Determination Letter on November 20, 2013. It was classified as a private foundation within the meaning of Section 509(a) and exempt from tax under Section 501(c)(3). The Foundation's initial return is for the calendar year 2013.

On May 12, 2014, the Foundation filed Form 8868, requesting an extension of time until August 15, 2014, in which to file its 2013 income tax return, Form 990-PF. On that date, the principal officer was out of town and unable to sign and file the return. Upon his return, the principal officer promptly signed and filed the return (attached).

The return was filed on August 22, 2014, seven days after its extended due date. There is no tax due with the filing of the return. This is the first year a return has been filed for the Foundation, and the principal officer was out of town and unavailable to review and sign and file the return on its due date. The principal officer is now aware of the importance of filing the Foundation's annual returns on their due dates and will insure that all future Foundation returns are timely filed.

The Internal Revenue Code and the Instructions for Form 990-PF provide that penalties may be waived if late filing was due to reasonable cause. The instructions for Form 990-PF state that the taxpayer must submit an explanation with its return.

Since the late filing of the return was inadvertent, filed late (but only seven days after its due date), was the initial return of the Foundation, the principal officer was out of town and unavailable to sign and file the return on its due date, and there was no tax due with the filing of the return, such late filing constitutes an inadvertent and harmless error, and on that basis the Foundation respectfully requests that any late-filing penalties be waived.
