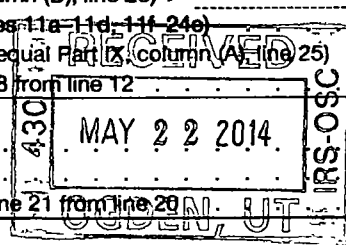

North by West hosted a solstice celebration in Oakland, CA. The event included local musicians, local arts and crafts vendors, and a seasonal ritual for community bonding. There was a slideshow by historian Max Dashu of the Suppressed Histories Archive about ancient religious practices of prehistory. There was also a film screening of Signs out of Times: The Life of Archaeologist Marija Gimbutas, which documents the life work of the distinguished archaeologist and her discoveries of the peaceful indigenous culture of prehistoric Europe. This was a day-long event to educate the public about the common roots of humanity's religious impulses. An estimated 2,000 people participated throughout the day.

4b (Code: 71120) (Expenses \$ 710 including grants of \$ 0) (Revenue \$ 5025)
N.W. hosted a break dance contest in Arcata, CA. The point of the contest was to engage underserved and at-risk youth in an area of California that is plagued by drug use and violence. Dance gives a creative community experience to alienated young people across ethnic and racial lines. Dancers brought their own music and performed their routines for an enthusiastic audience. Twenty-five dancers competed and an estimated five hundred came and went throughout the event.

4c (Code: 71110) (Expenses \$ 248 including grants of \$ 0) (Revenue \$ 3155)
N.W. organized a community read-along of Charles Dickens' A Christmas Carol. Participants volunteered to read the different characters out loud for the audience. Appropriate period music played in the background. The idea was to expose the community - children as well as adults - to the work of Charles Dickens and the music of his time. About 100 people attended.
