THOMAS HERITAGE CHARITABLE TRUST

Declaration of Trust made by Dwayne T. Friesen and Kathleen S. Friesen, Trustors, and Dwayne T. Friesen, Kathleen S. Friesen, Aaron T. Friesen, Rod J. Ray, and David K. Lyon as Trustees, who hereby declare and agree that they have received on November 27, 2013 from Dwayne T. Friesen and Kathleen S. Friesen, as Donors, the sum of Two Hundred Dollars (\$200) and that they will hold and manage the same, and any additions to it, in trust, as described in the eleven Articles that follow.

ARTICLE I

This trust is established on November 27, 2013 all provisions of this trust are effective on that date. This trust shall be called "**Thomas Heritage Charitable Trust**".

ARTICLE II

The trustees may receive and accept property, whether real, personal, or mixed, by way of gift, bequest, or devise, from any person, firm, trust, or corporation, to be held, administered, and disposed of in accordance with and pursuant to the provisions of this Declaration of Trust; but no gift, bequest or devise of any such property shall be received and accepted if it is conditioned or limited in such manner as to require the disposition of the income or its principal to any person or organization other than a "charitable organization" or for other than "charitable purposes" within the meaning of such terms as defined in Article Third of this Declaration of Trust, or as shall in the opinion of the trustees, jeopardize the federal income tax exemption of this trust pursuant to section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE III

A. The principal and income of all property received and accepted by the trustees to be administered under this Declaration of Trust shall be held in trust by them, and the trustees may make payments or distributions from income or principal, or both, to or for the use of such charitable organizations, within the meaning of that term as defined in paragraph C, in such amounts and for such charitable purposes of the trust as the trustees shall from time to time select and determine; and the trustees may make payments or distributions from income or principal, or both, directly for such charitable purposes, within the meaning of that term as defined in paragraph D, in such amounts as the trustees shall from time to time select and determine without making use of any other charitable organization. Whenever in this Declaration of Trust reference is made to the decision, consent, approval, judgment, or action of the trustees, unless otherwise expressly provided in this Declaration of Trust, such decision, consent, approval, judgment, or action shall mean a majority of the trustees. Income or principal derived

from contributions by corporations shall be distributed by the trustees for use solely within the United States or its possessions. No part of the net earnings of this trust shall inure or be payable to or for the benefit of any private shareholder or individual, and no substantial part of the activities of this trust shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. No part of the activities of this trust shall be the participation in, or intervention in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office.

B. The trust shall continue forever unless the trustees terminate it and distribute all of the principal and income, which action may be taken by the trustees in their discretion at any time. On such termination, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. The donor authorizes and empowers the trustees to form and organize a nonprofit corporation limited to the uses and purposes provided for in this Declaration of Trust, such corporation to be organized under the laws of any state or under the laws of the United States as may be determined by the trustees; such corporation when organized to have power to administer and control the affairs and property and to carry out the uses, objects, and purposes of this trust. Upon the creation and organization of such corporation, the trustees are authorized and empowered to convey, transfer, and deliver to such corporation all the property and assets to which this trust may be or become entitled. The charter, bylaws, and other provisions for the organization and management of such corporation and its affairs and property shall be such as the trustees shall determine, consistent with the provisions of this paragraph.

C. In this Declaration of Trust and in any amendments to it, references to "charitable organizations" or "charitable organization" mean corporations, trusts, funds, foundations, or community chests created or organized in the United States or in any of its possessions, whether under the laws of the United States, any state or territory, the District of Columbia, or any possession of the United States, organized and operated exclusively for charitable purposes, no part of the net earnings of which inures or is payable to or for the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation, and which do not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. It is intended that the organization described in this paragraph C shall be entitled to exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

D. In this Declaration of Trust and in any amendments to it, the term "charitable purposes" shall be limited to and shall include only religious, charitable, scientific, literary, or educational purposes within the meaning of those terms as used in section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future

federal tax code, but only such purposes as also constitute public charitable purposes under the law of trusts of the State of Oregon.

E. Any other provisions of this instrument notwithstanding, the trustees shall distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Any other provisions of this instrument notwithstanding, the trustees will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code; nor retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code; nor make any investments in a manner as to incur tax liability under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code; nor make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The primary purpose of this trust is to further the cause of Christ in the world as described in Christ's teachings as recorded in the New Testament of the Bible. Included in this definition of Christ's purpose are:

- 1) Promoting the salvation of individuals (evangelism; Matthew 28:19);
- 2) Educating, teaching and training Christ's followers;
- 3) Promoting adherence to Christ's teachings;
- 4) Helping the needy through physical and spiritual support.

It is therefore the responsibility of the Trustees to distribute such amounts of income and principal from the trust for such purposes and primarily to charitable organizations they reasonably believe support this purpose. In addition, the Trustees shall respect donor preferences for distributions provided the donor's preferred charitable organizations are supported by this Trust and such distributions comply with Article III, paragraph C herein. Exemplary organizations that meet these requirements include, but are not limited to:

- A.** Class 1: Churches that the donors attend or actively support;
- B.** Class 2: Christ-centered colleges, universities or other educational organizations that the donors support;
- C.** Class 3: Missions organizations that promote evangelism and humanitarian aid in the US as well as foreign countries.

Specific Examples of such organizations include, but are not limited to the following tax-exempt charitable organizations:

1. Class1:

- a) Christian Life Center; Bend, OR; and,
- b) Faith Center, Eugene, OR.

2. Class 2:

- a) Fuller Theological Seminary, Pasadena, CA; and,
- b) New Hope Christian College, Eugene, OR.

3. Class 3:

- a) Billy Graham Evangelistic Association;
- b) Samaritan's Purse, Boone NC;
- c) PATH Ministries, Bend, OR; and,
- d) Global Missions of Open Bible Churches.

The above listed organizations are listed solely to help clarify those organizations that are believed to be consistent with the stated purpose of this trust. It is anticipated that the trustees may choose to support charitable purposes and organizations not explicitly mentioned in the above list.

ARTICLE V

This Declaration of Trust may be amended at any time or times by written instrument or instruments signed and sealed by the trustees, and acknowledged by any of the trustees, provided that no amendment shall authorize the trustees to conduct the affairs of this trust in any manner or for any purpose contrary to the provisions of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. An amendment of the provisions of this Article Fifth (or any amendment to it) shall be valid only if and to the extent that such amendment further restricts the trustees' amending power. All instruments amending this Declaration of Trust shall be noted upon or kept attached to the executed original of this Declaration of Trust held by the trustees.

ARTICLE VI

The five individuals listed in Article IX are the Initial Trustees. Any trustee under this Declaration of Trust may, by written instrument, signed and acknowledged, resign his office. The number of trustees shall be at all times not less than two, and whenever for any reason the number is reduced to one, there shall be, and at any other time there may be, appointed one or more additional trustees. Appointments shall be made by the Trustors listed in this document. Trustees shall serve for a one year term that is renewable annually by a written statement of the Trustors, or, if neither Trustor survives, the Initial Trustees named herein. Should no Initial Trustee named herein survive, appointment of Trustees for vacant positions and renewal of Trustee terms shall be

made by the remaining trustee or trustees for the time in office by written instruments signed and acknowledged. Any succeeding or additional trustee shall, upon his or her acceptance of the office by written instrument signed and acknowledged, have the same powers, rights and duties, and the same title to the trust estate jointly with the surviving or remaining trustee or trustees as if originally appointed. None of the trustees shall be required to furnish any bond or surety. None of them shall be responsible or liable for the acts or omissions of any other of the trustees or of any predecessor or of a custodian, agent, depositary or counsel selected with reasonable care. The one or more trustees, whether Initial Trustees or successor, for the time being in office, shall have full authority to act even though one or more vacancies may exist. A trustee may, by appropriate written instrument, delegate all or any part of his or her powers to another or others of the trustees for such periods and subject to such conditions as such delegating trustee may determine. The trustees serving under this Declaration of Trust are authorized to pay to themselves amounts for reasonable expenses incurred and reasonable compensation for services rendered in the administration of this trust, but in no event shall any trustee who has made a contribution to this trust ever receive any compensation thereafter.

ARTICLE VII

In extension and not in limitation of the common law and statutory powers of trustees and other powers granted in this Declaration of Trust, the trustees shall have the following discretionary powers.

A. To invest and reinvest the principal and income of the trust in such property, real, personal, or mixed, and in such manner as they shall deem proper, and from time to time to change investments as they shall deem advisable; to invest in or retain any stocks, shares, bonds, notes, obligations, or personal or real property (including without limitation any interests in or obligations of any corporation, association, business trust, investment trust, common trust fund, or investment company) although some or all of the property so acquired or retained is of a kind or size which but for this express authority would not be considered proper and although all of the trust funds are invested in the securities of one company. No principal or income, however, shall be loaned, directly or indirectly, to any trustee or to anyone else, corporate or otherwise, who has at any time made a contribution to this trust, nor to anyone except on the basis of an adequate interest charge and with adequate security.

B. To sell, lease, or exchange any personal, mixed, or real property, at public auction or by private contract, for such consideration and on such terms as to credit or otherwise, and to make such contracts and enter into such undertakings relating to the trust property, as they consider advisable, whether or not such leases or contracts may extend beyond the duration of the trust.

C. To borrow money for such periods, at such rates of interest, and upon such terms as the trustees consider advisable, and as security for such loans to mortgage or

pledge any real or personal property with or without power of sale; to acquire or hold any real or personal property, subject to any mortgage or pledge on or of property acquired or held by this trust.

D. To execute and deliver deeds, assignments, transfers, mortgages, pledges, leases, covenants, contracts, promissory notes, releases, and other instruments, sealed or unsealed, incident to any transaction in which they engage.

E. To vote, to give proxies, to participate in the reorganization, merger or consolidation of any concern, or in the sale, lease, disposition, or distribution of its assets; to join with other security holders in acting through a committee, depositary, voting trustees, or otherwise, and in this connection to delegate authority to such committee, depositary, or trustees and to deposit securities with them or transfer securities to them; to pay assessments levied on securities or to exercise subscription rights in respect of securities.

F. To employ a bank or trust company as custodian of any funds or securities and to delegate to it such powers as they deem appropriate; to hold trust property without indication of fiduciary capacity but only in the name of a registered nominee, provided the trust property is at all times identified as such on the books of the trust; to keep any or all of the trust property or funds in any place or places in the United States of America; to employ clerks, accountants, investment counsel, investment agents, and any special services, and to pay the reasonable compensation and expenses of all such services in addition to the compensation of the trustees.

ARTICLE VIII

The trustees' powers are exercisable solely in the fiduciary capacity consistent with and in furtherance of the charitable purposes of this trust as specified in Article III and not otherwise.

ARTICLE IX

In this Declaration of Trust and in any amendment to it, references to "trustees" mean the one or more trustees, whether original or successor, for the time being in office.


ARTICLE X

Amendment 2013-1 of the Declaration of Trust of Thomas Heritage Charitable Trust

Article I

Effective date

The provisions of this amendment to the Declaration of Trust of the Thomas Heritage Charitable Trust (Trust) shall be effective from November 27, 2013, the date of the establishment of the Trust

Article II

Purpose and title

This amendment shall be called the "Conflict of Interest Policy". The purpose of his policy is to protect the Trust's interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of a Trustee or Officer or other interested person of the Trust or might result in a possible excess benefit transaction. This policy is intended to supplement but not replace any applicable state and federal laws governing conflict of interest applicable to nonprofit and charitable organizations

Article III

Definitions

1. Interested Person

Any trustee, officer, or member of a committee with trustee delegated powers, who has a direct or indirect financial interest, as defined below, is an interested person

2. Financial Interest

A person has a financial interest if the person has, directly or indirectly, through business, investment, or family:

- a. An ownership or investment interest in any entity with which the Trust has a transaction or arrangement,
- b. A compensation arrangement with the Trust or with any entity or individual with which the Trust has a transaction or arrangement, or
- c. A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the Trust is negotiating a transaction or arrangement.

Compensation includes direct and indirect remuneration as well as gifts or favors that are not insubstantial.

A financial interest is not necessarily a conflict of interest. Under Article IV, Section 2, a person who has a financial interest may have a conflict of interest only if the Trustees or delegated committee decides that a conflict of interest exists.

Article IV

Procedures

1. Duty to Disclose

In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the trustees and members of committees with trustee delegated powers considering the proposed transaction or arrangement.

2. Determining Whether a Conflict of Interest Exists

After disclosure of the financial interest and all material facts, and after any discussion

with the interested person, he/she shall leave the trustee or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining Trustees or committee members shall decide if a conflict of interest exists.

3 Procedures for Addressing the Conflict of Interest

- a. An interested person may make a presentation at the trustees or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest.
- b. The Chair of the Trust or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement
- c. After exercising due diligence, the trustees or committee shall determine whether the Trust can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.
- d. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Trust's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement

Instructions for Form 1023 -25-

4 Violations of the Conflicts of Interest Policy

- a. If the trustees or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose
- b. If, after hearing the member's response and after making further investigation as warranted by the circumstances, the Trustees or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Article V

Records of Proceedings

The minutes of the Trustees and all committees with trustee delegated powers shall contain.

- a. The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the Trustees' or committee's decision as to whether a conflict of interest in fact existed.
- b. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection with the proceedings

Article VI

Compensation

- a. A voting member of the Trustees who receives compensation, directly or indirectly, from the Trust for services is precluded from voting on matters pertaining to that member's compensation

- b. A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Trust for services is precluded from voting on matters pertaining to that member's compensation.
- c. No voting member of the Trustees or any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Trust, either individually or collectively, is prohibited from providing information to any committee regarding compensation

Article VII

Annual Statements

Each Trustee, officer and member of a committee with trustee delegated powers shall annually sign a statement which affirms such person

- a. Has received a copy of the conflicts of interest policy,
- b. Has read and understands the policy,
- c. Has agreed to comply with the policy, and
- d. Understands the Trust is charitable and in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.

Article VIII

Periodic Reviews

To ensure the Trust operates in a manner consistent with charitable purposes and does not engage in activities that could jeopardize its tax-exempt status, periodic reviews shall be conducted. The periodic reviews shall, at a minimum, include the following subjects:

- a. Whether compensation arrangements and benefits are reasonable, based on competent survey information, and the result of arm's length bargaining
- b. Whether partnerships, joint ventures, and arrangements with management organizations conform to the Trust's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes and do not result in inurement, impermissible private benefit or in an excess benefit transaction.



Amendment 2013-2 to the Declaration of Trust of Thomas Heritage Charitable Trust

Article I

Effective date

The provisions of this amendment to the Declaration of Trust of the Thomas Heritage Charitable Trust (Trust) shall be effective from November 27, 2013, the date of the establishment of the Trust.

Article II

Purpose

The purpose of this amendment to the Declaration of Trust is to establish government, operation and Officers as well as to appoint the Initial Officers of the Trust for conducting the business of the Trust. This amendment is intended to supplement but not replace the provisions of the Declaration of Trust and to clarify that the Trustees delegate as described herein a portion of their authority and rights to the Officers of the Trust.

Article III

Definitions

1. Officers

"Officers" shall mean all officers of the Trust established through this or future amendment by the approval of the Trustees. As set forth in this amendment, the Officers shall consist of a Chair and a Secretary-Treasurer

2. Initial Officers

"Initial Officers" shall mean the individual appointed to serve as Officers through this amendment.

Article IV

Procedures

1. Appointment of Officers

The Initial Officers of the Trust shall be appointed through this amendment

2. Term of Officers

The appointed Officers shall serve till said Officers choose to resign their position or the Trustees choose for any reason to replace an existing Officer

3. New Officers

The Trustees may at any time by majority vote appoint new Officers to replace existing Officers or fill a vacant Officer position

4. Record of Trustee actions and appointments

The Trustees shall keep and preserve minutes of meetings and document votes, decisions elections and appointments. Such meetings and actions may be conducted in person, by phone, by e-mail or other electronic communication or by written communication or any other reliable form of communication.

5. By-Laws

The Trustees may by majority vote adopt By-Laws not inconsistent with this Declaration of Trust. Such By-Laws must be consistent with all laws pertaining to the operation of a charitable trust and may not allow a Trustee or Officer to conduct the affairs of this Trust in any manner or for any purpose contrary to the provisions of section 501(c)(3) of the

Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V

Initial Officers

The following persons are appointed as Initial Officers to serve as Officers in their respective capacities until they choose to resign or are replaced by the Trustees according to the provisions of Article IV of this amendment.

1. Chair

The Trustees hereby appoint Dwayne T. Friesen, Trustor and Trustee to serve as Chair.

2. Secretary-Treasurer

The Trustees hereby appoint Kathleen S. Friesen, Trustor and Trustee to serve as Secretary-Treasurer.

Article VI

Authority and Duties of Officers

1. Chair

The Chair shall preside over meetings of the Trustees whether in person or via other oral or written communication. The Chair is delegated by the Trustees to conduct the business, financial and affairs of the Trust subject to the control and direction of the Trustees. The Chair shall see that the resolutions and directives of the Trustees are carried out. The Chair shall have the right and responsibility, in conjunction with the Secretary-Treasurer, to have charge and custody of all assets, funds and securities of the trust. This shall include establishment of accounts at banks, investment companies or other depositories as the Chair and Secretary-Treasurer deem appropriate for the receipt, care, investment and disbursement of all Trust assets and funds. This right shall include distribution of charitable contributions, gifts, grants or other permissible disbursements as directed by the Trustees. The Chair shall at least annually recommend to the Trustees charitable contributions, gifts, grants or other permissible disbursements from the assets of the Trust. In addition, the Chair shall have the right to directly or through the secretary-treasurer expend Trust funds for expenses necessary for carrying out the business of the Trust. Such expenses shall include but not be limited to the payment of any fees or taxes imposed by a government agency, the payment of professionals for legal, financial and accounting services and reimbursement of direct expenses of individuals carrying out the business of the Trust. However, this right shall not allow the hiring of any employee of the Trust or payment of any funds to the Officers or Trustees of the Trust without the approval of the Trustees and then only if permitted by the provisions of the Declaration of Trust. The trustees hereby delegate to the Chair all rights of the Trustees recited in Article VII of the Declaration of Trust with respect to investment of Trust assets. That is, "To invest and reinvest the principal and income of the trust in such property, real, personal, or mixed, and in such manner as they shall deem proper, and from time to time to change investments as they shall deem advisable; to invest in or retain any stocks, shares, bonds, notes, obligations, or personal or real property (including without limitation any interests in or obligations of any corporation, association, business trust, investment trust, common trust fund, or investment company) although some or all of the property so acquired or retained is of a kind or size which but for this express authority would not be considered proper and although all of the trust funds are invested in the securities of one company." The Chair shall have the right to directly or through the Secretary-Treasurer transfer, purchase or sell funds, bonds, stocks, certificates of deposit or other securities. The Chair and Secretary-Treasurer are jointly responsible for reporting at least annually to the Trustees.





This right shall include distribution of charitable contributions, gifts, grants or other permissible disbursements as directed by the Trustees. The Secretary-Treasurer shall have the responsibility and right to disburse funds as directed by the Chair or by direction or resolution of the Trustees for payment of the expenses of the Trust. In addition, the Secretary-Treasurer shall have the right to transfer funds, purchase bonds, stocks certificates of deposit or other securities as directed by the Chair. The Secretary-Treasurer may receive contributions or funds owed the Trust and give receipts for monies or other assets received in the name of the Trust. The Secretary-Treasurer is responsible for keeping all financial records and reporting to the Trustees at least annually on all funds received and disbursed. The Secretary-Treasurer, in conjunction with the Chair, are also responsible to file all registration or financial reports as required by law for the Trust and to apply for and maintain all documents for recognition of exemption under 501(c)(3) of the Internal Revenue Code





Purpose of Thomas Heritage Charitable Trust

This document is intended to describe the purpose of the Thomas Heritage Charitable Trust. Thomas Heritage Charitable Trust was established in honor of Frank and Clara Thomas, dedicated and exemplary followers of Christ. Throughout their lives, Frank and Clara honored Christ by generously and sacrificially giving wherever they saw an unmet need – expecting nothing in return except the knowledge of blessing others as their Lord had so graciously blessed them.

In that same spirit, Thomas Heritage Charitable Trust was established to further the cause of Christ through gifts for charitable purposes and to charitable organizations that are meeting unmet spiritual and physical needs throughout the world.

The purpose of Thomas Heritage Charitable Trust is further described in Article IV of the Declaration of Trust that founded the Trust. Article IV is reproduced in its entirety below.

ARTICLE IV

The primary purpose of this trust is to further the cause of Christ in the world as described in Christ's teachings as recorded in the New Testament of the Bible. Included in this definition of Christ's purpose are:

- 1) Promoting the salvation of individuals (evangelism; Matthew 28:19);
- 2) Educating, teaching and training Christ's followers;
- 3) Promoting adherence to Christ's teachings;
- 4) Helping the needy through physical and spiritual support.

It is therefore the responsibility of the Trustees to distribute such amounts of income and principal from the trust for such purposes and primarily to charitable organizations they reasonably believe support this purpose. In addition, the Trustees shall respect donor preferences for distributions provided the donor's preferred charitable organizations are supported by this Trust and such distributions comply with Article III, paragraph C herein. Exemplary organizations that meet these requirements include, but are not limited to:

- A. Class 1: Churches that the donors attend or actively support;
- B. Class 2: Christ-centered colleges, universities or other educational organizations that the donors support;
- C. Class 3: Missions organizations that promote evangelism and humanitarian aid in the US as well as foreign countries.

Specific Examples of such organizations include, but are not limited to the following tax-exempt charitable organizations:

1. Class1:

- a) Christian Life Center; Bend, OR; and,
- b) Faith Center, Eugene, OR.

2. Class 2:

February 10, 2014

- a) Fuller Theological Seminary, Pasadena, CA; and,
- b) New Hope Christian College, Eugene, OR.

3. Class 3:

- a) Billy Graham Evangelistic Association;
- b) Samaritan's Purse, Boone NC;
- c) PATH Ministries, Bend, OR; and,
- d) Global Missions of Open Bible Churches.

The above listed organizations are listed solely to help clarify those organizations that are believed to be consistent with the stated purpose of this trust. It is anticipated that the trustees may choose to support charitable purposes and organizations not explicitly mentioned in the above list.

Although it is understood that it is up to the Trustees to interpret the purpose of the Trust in approving how Trust funds are distributed, it is also the duty of the Trustees to do their best to utilize Trust funds in a manner that best adheres to the Purpose of the Trust.
