

These spaces provide healing and transformation and connect members to themselves and their communities. Members develop analysis, strengthen leadership skills, and build a powerful vision for the future.
YOUTH: Developing a new generation of leaders:
- YOUTH SPACE: Empowers Black youth ages 12-19 by creating a space that empowers them to develop an analysis and create a vision for changing conditions within their schools and communities.
- BABY BOP: A summer Arts program for children ages 4-11 that nurtures them to thrive and grow. Baby BOP invites children to explore their identity and history through experiential learning led by community teachers.
- INTERNSHIPS: We bring youth into appropriate roles in all of BOP's work.

In BOP's case, an additional \$99,505 in net assets represents the assets received (net of expenses) by the fiscal sponsor prior to the income and expense represented in this 990. This addition to net assets is essentially a transfer at the time that BOP became an independent entity. This is a one-time adjustment in the start-up year. Although the fiscal sponsor still held cash and receivables on BOP's behalf at the end of 2013, those are being reported herein as BOP assets rather than as assets of the fiscal sponsor.
