THE FOUNDATION RELIED ON THE ATTORNEY'S ADVICE AND WAS NOT AWARE OF FILING REQUIREMENTS WHILE HE WAS WAITING ON APPROVAL. THERE WAS ZERO ACTIVITY DURING 2013.

AFTER THE ORGANIZATION DISCOVERED THE REQUIREMENT TO FILE THEY TOOK IMMEDIATE STEPS AND HIRED CPA TO COMPLY WITH PRIOR YEAR FILING REQUIREMENTS.
