

Fun 5: Afterschool fitness and nutrition program: Kahoomiki manages the statewide Fun 5 program, with activities in 180 schools on all Hawaiian Islands (except Niihau), with more than 18,000 elementary school children participating. Each site has an on-site coordinator, and individual group leaders who work directly with the children each day after school. Kahoomiki provides twice-yearly training on physical activity and nutrition education for these site coordinators and group leaders (some 800+); provides operational manuals to support training activities; provides playground equipment and nutrition education equipment to each site; provides evaluative follow-up; provides information about afterschool activities in Hawaii. Program is funded primarily by service grants from private foundations and businesses. Success is measured by number of school sites that participate, number of students enrolled, degree of implementation at the local level, and involvement of group leaders in the training sessions. Reduced funding in 2013 required reduction in the number of training sessions for group leaders from 33 to 16; no distribution of play equipment or nutrition materials.

Aloha State Games: Kahoomiki organizes and manages the activities of this statewide multi-sport event in the Islands. Games activities take place in June and July, and are organized primarily by volunteers. Primary source of funds is entry fees. Approximately 2,000 participants, all amateurs. Success is measured by number of sports recruited, number of participants.

Keiki Fun Run: A community fun run designed to impress upon children the importance of staying physically active. In 2013, there were 1500+ participants from more than five dozen elementary schools on Oahu. Participants earned credits for their school's PE program by participating in the run.

Part III, No. 2: Kahoomiki was asked to lead an effort to establish a network of organizations and individuals involved in afterschool programs for school children. Kahoomiki began that effort during 2013.

Part III, No. 3: Kahoomiki experienced significant reduction in grant support during 2013 and, as a result, greatly reduced the extent of its training efforts through the Fun 5 program.

Part III, No. 4d: Other programs – at the request of others, Kahoomiki undertook organization of a statewide afterschool network; Hawaii was one of seven states that did not then have such a network. This effort involved forming a steering committee of representatives of afterschool providers organizing a summit of those and others statewide, and formulating a plan for purpose, structure and governance of such an entity. Kahoomiki also served as the organizer of the Hawaii Senior Olympics, a multi-sport event for persons 50+ years of age. Those games involve about a dozen different sports, with approximately 300 participants. Their purpose is to encourage seniors to remain physically active as a means of maintaining health. Both projects were small and limited during the year.
