No one in the organization can remember who was handling the 501(c) paperwork requirements, but all the older members believe it was one of the
nuns that is now deceased. The new officers are attempting to bring the organization into good standing. However, records prior to 2012 when the
current officers took office are missing. The past president and vice president are deceased. The Treasurer from that time is now 92 years old and
not able to provide information. She did not turn over any records as she was voted out under hostile circumstances and resentful of relinquishing
