Emergency Assistance Programs Emergency Services provided rent and utility assistance for one month, or more for those participating in extended case management services, for 590 households consisting of 767 children and 897 adults The extended case management services are designed for those households where there are extenuating circumstances that have caused financial stress threatening displacement of family members People receiving this assistance must be working or have only recently lost a job and are actively seeking another Other programs providing emergency assistance include the clothing closet, emergency closet, and food pantry During 2013, 594 households received clothing items from the clothing closet These households were made up of 845 children and 957 adults Diapers were distributed for babies and toddlers to 1,014 households The emergency supply closet supplied household needs, such as personal care items and toilet paper to 2,207 households Our front desk volunteers, 50 volunteers each month working 4 hour shifts, are heavily involved in the emergency assistance programs with distribution of emergency supplies and appointment calls

Hunger Relief The emergency food pantry served 2,292 households during the year with a several days supply of food Of the total 6,121 family members served, 2,372 were children The Don Bakely Community Annex Food Program served 13,846 weekday breakfasts and 38,008 hot lunches to families and individuals during the 2013 year Sack lunches were provided to those looking for a job or who are working with a total of 5,590 sack lunches provided in 2013 Volunteers are crucial to this program and approximately 8 people volunteer each weekday to prepare and serve the meals This is a total of 160 volunteers each month serving 4 to 5 hour shifts The Don Bakely Community Annex Personal Care Program provided 810 loads of laundry and 2,064 showers to meet the personal care needs of clients The Commodities Food Distribution Program served 15,136 people with a monthly distribution of nourishing, supplemental food Participants in this program are mostly elderly and on a fixed income, often only consisting of social security benefits They come from Johnson, Wyandotte, and Leavenworth Counties in Kansas The community garden produced 4,729 pounds of healthy food that was distributed through the food pantry and used in the Don Blakely Community Annex for the food program Surplus vegetables were sold at deeply discounted prices to people in the community The Amourdale neighborhood, where Cross-Lines is located, is without a grocery store and access to fresh produce (these areas are called 'food deserts') so this meets a critical need in the community The garden relies on volunteers to prepare, plant, harvest, and close the garden each year A core group of 8 volunteers provide consistent care and oversight of the garden with 260 volunteers providing additional help and labor throughout the year

Highlights Programs are planned to increase the self respect and feelings of self worth of those who come to Cross-Lines for services Children and youth, especially, are thought of as we provide school supplies and uniform shirts, clothing and toys for Christmas With the help of these programs, families can enjoy experiencing something that is not handed down from an older family member and the joy of providing toys and clothing that the parent selected for the child from the Christmas store Over 500 volunteers are involved in the Christmas Store which assisted 504 Families with NEW items of clothing, housewares, toys, and food More than 728 students returned to school with new backpacks and school supplies for the 2013-14 school year Uniform clothing was supplied to 220 students More than 150 volunteers are involved in the Back to School Program
