Riley County Senior Service Center (RCSSC)
Mission: To provide services and activities for older adults age 60 years and above living in Riley County, KS. The Center served 5,200 individuals in 2013; the total number of participants in all activities was 46,000. The Riley County Council on Aging provided 68% of the Center's funding; the remainder of its funding was raised by the Center's various activities. Approximately 65 volunteers provided 3,400 hours of volunteer services in almost every facet of Center operations and services. Using minimum wage comparisons, these volunteers donated \$24,650 in-kind to the Center. The City of Manhattan (KS) provides the building

Homecare and Hospice, Inc.
Mission: Funding provided by the Riley County Council on Aging was used in the Health Care Attendant Program, which involves providing assistance to clients in need of bathing, medication reminders, dressing, grooming, and toilet needs under the direction of a licensed health care professional. Volunteers provide assistance with light housekeeping duties, laundry, essential shopping errands, and meal preparation. For 2013, the Health Care and Hospice Attendant Program provided services to 144 unduplicated clients. Approximately 2,939 hours of volunteer service were provided Homecare and Hospice, Inc. It is the only Agency provider of Older American Act services in Riley County. It's services include: Care Management Programs; Bereavement Support Groups; Transition Services Programs; Transportation Services; Cancer Resource Task Force; Riley County Council of Social Service Agencies; and the Annual Flu Vaccination and Tuberculosis Testing Programs.

RSVP of the Flint Hills, Inc.
Mission: To provide opportunities for those 14 years and older to volunteer their services and to make a difference in their community. It is a one-to-one volunteer referral agency serving residents throughout Riley, Pottawatomie, and Geary County in Kansas. RSVP matches the skills and interests of its pool of volunteers with the needs of service organizations already helping area residents. About 356 RSVP volunteers serve at 58 volunteer stations in our service area. Annually, these volunteers contribute over 35,694 hours of volunteer service. These volunteer activities included working in a local clinic; area blood drives, making and distributing over 1,000 items to local communities; providing transportation to elderly; tutoring; CASA advocates; and teaching reading skills to students. The value wage for 2013 volunteer hours served is \$380,097
