courtrooms, local government officials and the media. In 2013, the Legal Foundation published 16 articles in the Kansas Farm Bureau Leader Letter that is disseminated to over 36,000 individuals. These articles include topics, such as: Affordable Care Act, Greenhouse Gas Rules, Year-End Tax Tips, Trucking Regulations, Retirement Planning, Use of Drones, Livestock At Large, Agri-tourism, Walk in Hunting and Kansas Recreational Use.

In addition, the Legal Foundation staff provided over 25 educational seminars to approximately 1,000 individuals, regarding oil & gas leases, transmission line easements, fencing, farm leases, agri-tourism, spray drift, zoning, succession/estate planning and KARL program. Impacted groups were KFB members, K-State Extension and Women Managing the Farm program. Also, staff prepared public comments, concerning the proposed Black-footed Ferret Safe Harbor Agreements to the USFWS. Further, the Legal Foundation staff prepared White Papers for Transmission Line and Eminent Domain issues. It also, worked on agricultural land reclassification, water flow meters zoning, drones, data mining and numerous energy concerns.

Finally, the Legal Foundation works with organizations such as the Kansas Bar Association (KBA) and Kansas State Extension (KSU). The Legal Foundation in cooperation with the KBA hosts Agricultural Law Seminars for attorneys from around the State of Kansas. The hope is to educate rural,
