FIRST AMENDMENT TO
DECLARATION OF TRUST (RESTATED)

THIS FIRST AMENDMENT TO DECLARATION OF TRUST (RESTATED) is made this 21st day of October, 2011, by H. Russell Bomhoff and M. Ilene Bomhoff, as Trustees, and H. Russell Bomhoff, as Settlor.

WHEREAS, by Declaration of Trust dated February 1, 2001, H. Russell Bomhoff, as Settlor, and H. Russell Bomhoff, as Trustee, created a charitable trust called the "Bomhoff Foundation."

WHEREAS, Article IV of the Declaration of Trust permits amendments to be made by the Trustees with the written notarized consent of the Settlor being required for any amendments of Article V or paragraph I of Article VI.

WHEREAS, on November 3, 2006, H. Russell Bomhoff, as Settlor, and H. Russell Bomhoff, as Trustee, amended and restated the Declaration of Trust in its entirety.

WHEREAS, the Settlor and Trustee wishes to further amend the Declaration of Trust.

NOW THEREFORE, in consideration of the premises, the Bomhoff Foundation is amended as follows:

1. Article V of the Declaration of Trust shall be deleted in its entirety and a new Article V inserted to read as follows:

"A. In the event the Settlor is not serving as a Trustee hereunder, but there is at least one individual successor Trustee who is serving, then twelve and one-half percent (12 ½%) of the annual distributions shall be made to each of the following organizations:

Inter-Faith Ministries, Wichita, Kansas,
United Way of the Plains, Wichita, Kansas,

and at least sixty-five percent (65%) of the annual distributions shall be made to the following organizations in whatever proportions the Trustee deems appropriate from time to time:

United Methodist Youthville, Wichita, Kansas,
American Red Cross, Wichita, Kansas,
Wichita Children's Home, Wichita, Kansas,
Salvation Army, Wichita, Kansas,

Heartspring, Wichita, Kansas, and
The Wichita State University for the H. Russell Bomhoff Endowed
Scholarship in Engineering and the H. Russell Bomhoff Endowed
Professorship in Engineering,

for their operations, programs or activities in Kansas.

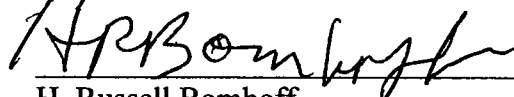
The remaining distributions shall be made in whatever manner the Trustee shall deem appropriate within the limitations imposed upon charitable organizations qualifying under § 501(c)(3) of the Internal Revenue Code of 1986, as amended."

B. In the event the Settlor is not serving as a Trustee hereunder and there is not at least one individual successor Trustee who is serving, then the Wichita Community Foundation, Wichita, Kansas, shall become the successor Trustee. At that point the Trustee shall terminate the Bomhoff Foundation and distribute the entire trust estate to the Wichita Community Foundation, Wichita, Kansas, to be held as part of the donor advised endowed fund established by Settlor known as the "H. Russell Bomhoff Fund," or if no such donor advised fund is then in existence, to the Wichita Community Foundation, Wichita, Kansas to be held in perpetuity as an endowed directed fund to be called the "H. Russell Bomhoff Fund." The distributions from said H. Russell Bomhoff Fund shall be made to the organizations listed in paragraph A above in whatever proportions the Wichita Community Foundation deems appropriate from time to time.

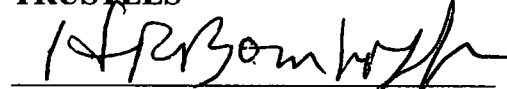
