The NACDS Foundation provides crucial Scholarship programs to Pharmacy Schools and individual Pharmacy students throughout the United States. 51 of the 130 U.S. based Pharmacy Schools and 4 individual Pharmacy students were awarded scholarships this year. The pharmacy school awards are designated for the school's scholarship funds for students.

The Foundation also offers education programs and resources for pharmacists, pharmacy schools, pharmacy students and the general public on public health issues.

Research: The NACDS Foundation provides solicited funding for projects that advance its mission to improve the health and wellness of those living in the U.S. through medication management. Through grantmaking, it seeks to improve the health and welfare of patients. The NACDS Foundation funded 7 research grants in 2013.
