The greatest portion of funds handled by The Great Commission, Inc is given directly to individual missionary ministries That amount was \$441,413 in 2013 It is the policy of The Great Commission, Inc to give 100% of designated gifts to the individual ministries for which the gifts were designated without any deduction of administrative costs for The Great Commission, Inc The Great Commission pays its administrative expenses using funds not designated to any specific missionary ministry These general gifts are placed into the general fund to pay administrative expenses and to fund special missionary projects chosen by the board of directors of The Great Commission, Inc

The Great Commission, Inc funded many special missionary projects in 2013 The funds for these projects are received as undesignated gifts and placed into the general fund The board of directors of The Great Commission then designates funds to various special missionary projects as they arise Our medical fund for current and retired missionaries has met special medical needs An amount of \$7,196 was used to provide medical care for these missionaries Other significant projects include \$7,060 to provide tuition for missionary children's schooling, \$395 for Muslim prayer booklets, and \$4,000 to purchase and prepare equipment for a Mongolian family, and \$500 for a solar battery system in Haiti The total of other miscellaneous projects not mentioned above was \$5655
