The Foundation responded to the express needs of STFM members for funding research and education by establishing the Group Project Fund in 2008. It was designed to reward creative and collaborative proposals of STFM group members. The outcomes of the projects will benefit group members, the Society of Teachers of Family Medicine, and the discipline of family medicine.
