Over the past decade we have developed innovative math programs for primary (grades K-5) and middle school (grades 6-8). In 1999 we published "Bridges in Mathematics" Grade 2 and subsequently published Grade 1 in 2000, Grade K in 2001, Grade 3 in 2005, Grade 4 in 2006, and Grade 5 in 2007. In 2013 we published "Bridges in Mathematics" second edition for grades K-2, grades 3-5 will be published in 2014. Through 1998 we received significant funding from the National Science Foundation for the development of the curriculum and materials. Since then we have been self-funded through the sale of these materials to school districts as well as individual teachers. We believe that simply publishing innovative programs is not enough. Our experience, and a growing body of research, has shown us that teachers need support and training for successful implementation in the classroom. We offer a variety of services from workshops to consulting to online resources. Workshops are offered throughout the United States and usually carry graduate credit from Western Oregon University.
