3. Student MVP

1. Kids Night Out

Kids Night Out allows local non-profit agencies the opportunity to host the children and families they serve, many who might never have the chance to experience a professional sporting event, at a Minor League Baseball game. Kids Night Out allows children to witness the results of hard work, dedication, and teamwork – qualities needed to excel in all aspects of life. This program takes place twice during the year, and serves over 2,500 underprivileged and underserved children from across North Texas.

2. Grants and Donations

The RoughRiders Foundation allocates a portion of its budget to grants and donations, which are awarded to numerous nonprofits throughout the year. The goal of this program is to assist organizations that help and support children and families, specifically in the area of education, good health and community service. Organizations awarded \$500-\$1,000 grants must submit a grant application form and are considered for these donations on a rolling basis through July of each year. In 2013, the Foundation donated \$26,340 to nonprofit organizations serving the community.

3. Student MVP

The RoughRiders MVP Student program is designed to be an instrument for teachers to reward, motivate and honor their students. The program utilizes RoughRiders tickets as the "tool". The program is targeted at fifth grade teachers and students.

The RoughRiders have partnered with many local school districts this year to bring the MVP Student Program into their classrooms. MVP students and their families not only receive free tickets to a RoughRiders game, but also a unique opportunity to meet some RoughRiders players and Deuce! Each MVP student also receives an exclusive souvenir to show off to their friends. In excess of 1,500 students participated in this program in 2013.
