ICPI established this program to support trainee participation in scientific meetings
organized by its member societies. The award is intended to offset the travel cost

graduate student, resident, or fellow) member of one of the sponsoring societies or
associate members of ICPI. In 2013, ICPI awarded 27 travel awards.
