HALFWAY HOUSE PROGRAM The operation of the Halfway House is funded through the District of Columbia Department of Corrections and the Federal Bureau of Prisons. There are a maximum of 40 residents housed on any one day of the year. During 2013, a total of 175 men on parole or in work-release programs were serviced. The major objectives of EFEC's Halfway House are 1) to promote self-help programs to ex-offenders desiring to rehabilitate themselves to fully accept their rights and responsibilities as citizens, and 2) to provide education improvements for ex-offenders who desire to better their skills and take advantage of opportunities available to those with proper training
