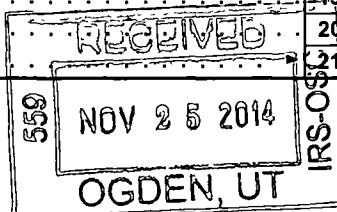

Statement of Program Service Accomplishments

Ghana Sponsorship and Rescue Programs

Total Grants Paid: \$21,909.56

In 2013, the U.S. Association for International Migration (USAIM) continued supporting the rescue, rehabilitation and reintegration of trafficked children who have been forced to perform forced labor in fishing communities on Lake Volta in Ghana.

The sponsorship program provided extensive support to five children who had been rescued in 2011, including the provision of meals, school supplies, uniforms, and books to enable the children to attend school. Monthly monitoring visits were provided to both the children and the parents/guardians to ensure that the reunification and reintegration continued to be sustainable, the risk of re-trafficking low and the children were thriving in healthy and safe environments.

Furthermore, efforts to plan and organize a rescue of 20 children currently trapped in dangerous trafficking situations began in 2013. The process includes identifying children in need of a rescue, conducting family tracing to find suitable guardians to care for the children once rescued, and working with community partners to plan for the rescue. The rescue is scheduled to take place in 2015.

Typhoon Haiyan Program

Total Grants Paid: \$9,238.50

In 2013 USAIM supported relief efforts for victims of Typhoon Haiyan which struck the Philippines on November 8, 2013 and displaced over 4 million people. Relief efforts included the distribution of blankets, shelter repair kits, family emergency kits, kitchen kits and chainsaws for debris removal. Furthermore, USAIM supported the reconstruction of the Tagpuro Boys Shelter in Tacloban, Philippines which had been destroyed during the storm. The repaired shelter provides a safe haven for out-of-school boys who do not have guardians to look after them.

Haiti Food Assistance Program

Total Grants Paid: \$1,888.33

In 2013 USAIM provided holiday meals to 46 children at two orphanages in Port au Price, Haiti. The assistance reached 30 young girls at *Foyer de l'Espoir* and 16 girls and boys at *Foyer des Enfant* who lost their homes and families after the 2010 earthquake. These children critically needed food assistance and USAIM's support made their holiday celebration fun and meaningful.
