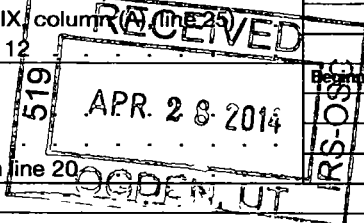

A Key Encounter is an outreach program for locals and visitors in the Florida Keys. Thru 9-15-13, we offered a free nature theater, a free planetarium presentation, and free books and magazines, all pointing to God as the one who created and is available to recreate all into His image. After 8-22-13, the same message is broadcast on our Christian FM radio station (local and internet) which offers music, religious, health and children's programs, all pointing to God as the answer for life's challenges.

Thru 9-15-13 we operated our facility in an enclosed mall in Key West. New mall management bought out our lease, in order to reconfigure and update the mall. Until closing, we offered a free 20-minute nature presentation, filmed locally, and presented on three large screens, which taught appreciation for God's creation in the Florida Keys. Using a state-of-the-art planetarium in a free 20-minute presentation, we showed the history of astronomy, pictures from the Hubble telescope, and other cosmic events, including a graphic depiction of the future according to Holy Scripture. After viewing the planetarium, guests were offered spiritually educating CD's, DVD's, and other material. All visitors to the facility were encouraged to take a free magazine and other material to learn how to deal with the stresses of life from a spiritual, mental, and physical point of view.
On 8-22-13, we received a FCC permit and began operating a Christian FM radio station which offers music, religious, health and children's programs. We are educating individuals via the body, mind, and spirit showing God as the answer for life's challenges. WHNJ (Whole Health 'N' Joy) is available at 95.7 FM in the mid and lower Florida Keys, and at whnj.org on the internet reaching listeners around the world.

***FORM 990 - Part XI - Line 9: Explain other changes in net assets -- (\$15,035)

During 2013, the owner of the enclosed mall where we were located engaged a new management team who cancelled our lease, even though we always paid on time. They divided our large space into several smaller shops, therefore destroying all the improvements we had put into our space which included a theater, a planetarium, a gift shop and cages for our exotic birds. As a result, we took a loss of \$15,035 on the leasehold improvements and other assets which were not fully depreciated.
