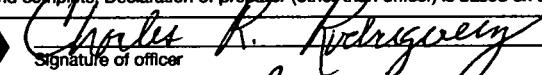

and sent to the treasurer for review and signature.

Compensation level of the chief executive is determined based on competitive salary schedules of like organizations.

Governing documents, conflict of interest policies and financial statements are made available to the public upon request.
