JUDICIAL INDEPENDENCE: Independence of the judicial branch is fundamental for the good function of the Rule of Law. Likewise, independence is a precondition for impartial application of the law -to all persons equally- and is an essential component for strengthening the judicial sector in Latin America. Thus, under our Judicial Independence Program we promote an independent judicial sector focusing on three areas: transparency and judicial corruption, selection of judicial officials, and the impact of undue pressures on the overuse of pretrial detention. In 2013, DPLF succeeded in placing the issue of judicial independence on the hemispheric agenda, including getting a number of our recommendations to be included in IACHR reports that address judicial independence issues. Our applied research is used by judicial officials, lawyers and activists in the region as well as international decision makers to promote more transparent and accountable judicial systems. We also published the following studies this year under this program: *Independencia judicial insuficiente, prision preventiva deformada: Los casos de Argentina, Colombia, Ecuador y Perú* (Insufficient judicial independence, deformed pre-trial detention: The cases of Argentina, Colombia, Ecuador and Peru); *Selecting the very best: The selection of high-level judges in the United States, Europe and Asia* (also available in Spanish).

HUMAN RIGHTS & EXTRACTIVE INDUSTRIES: The intense -and too often deadly- social conflicts erupting all over Latin America associated with the extraction of natural resources and major infrastructure development projects demand that host States, the corporations carrying out the projects, and the States from which international extractive companies hail comply with international and national human rights standards and norms. Furthermore, all stakeholders must recognize and respect the rights of indigenous groups to their land and territory, and their right to prior consultation in these projects. Through our Human Rights & Extractive Industries Program, DPLF promotes the use of existing international and national legal and institutional mechanisms in resolving conflicts related to natural resources extraction in coordination with international human rights norms and standards. Respect for the rights of those affected by these projects is fundamental for democracy and peace in Latin America. This year, through some strategic advocacy DPLF succeeded in getting the responsibility of Home States (the States from which international extractive companies hail) on the regional human rights agenda. This year DPLF published our *Digesto de jurisprudencia latinoamericana sobre los derechos de los pueblos indígenas a la participacion, la consulta previa y la propiedad comunitaria* (Digest of Latin American jurisprudence on the rights of indigenous Peoples to participation, prior consultation and community property).

STRENGTHENING THE INTER AMERICAN HUMAN RIGHTS SYSTEM: The inter American human rights protection system, which incorporates the Inter American Commission (IACHR) and Court on Human Rights, constitutes the regional framework for the protection and promotion of human rights in the Americas. The member States of the Organization of American States established the system and charged it with monitoring respect for the international human rights instruments they themselves ratified. Through our Strengthening of the Inter American Human Rights System Program, DPLF monitors the OAS on human rights issues and carries out applied research and advocacy activities, as well as promotes informed dialogue amongst users of the Inter American Human Rights System to promote continuation of the system's human rights legacy. In 2013 DPLF was instrumental in bringing about the first ever public forum of IACHR commissioner candidates. Such forums are preliminary steps towards a more transparent and participatory selection process, and in 2013 helped ensure that those candidates that were elected appear to be the most qualified of the candidates. DPLF, in close coordination with our local allies, continued to request and hold public thematic hearings before the IACHR seeking to focus attention on various issues related to our programmatic work.

The investigation, prosecution and reparation of past grave violations of human rights remain a pending debt in Latin America. This lack of justice has serious repercussions for the present, and reflects the weakness of the judicial systems in the region. This year our Transitional Justice Program sought to give Latin American judicial officials, lawyers, and human rights activist access to information on how other colleagues in the region have used and applied international human rights law in their own cases, in the hopes of encouraging them to apply international law. With two volumes of our Digest of Latin American Jurisprudence on International Crimes in hand (Volume II was issued in 2013) DPLF facilitates very open and technical discussion with judicial officials on how to overcome perceived obstacles to obtaining justice for crimes of the past. This year DPLF issued the 18th edition of our institutional magazine, AportesDPLF, focused on Current challenges in seeking justice for serious crimes of the past (in English and Spanish). (Expenses: \$108,550)
