The American National Standards Institute (ANSI) accredited the Green Advantage Certified Practitioner (GACP) certification under its ANSI/ISO/IEC 17024 personnel standard. Considered the "gold standard" for certifying bodies, this is a rigorous, internationally recognized, third-party accreditation of both Green Advantage as an organization as well as its GACP credential.

Already approved under LEED-NC v2.2 and LEED 2009 BD&C, the United States Green Building Council (USGBC) approved the use of Green Advantage Certified Practitioners meeting the Green Advantage Field Personnel Standard as a LEED Innovation Credit for eligible projects seeking LEED® Certification under the newest version of the rating system, LEED v4.
