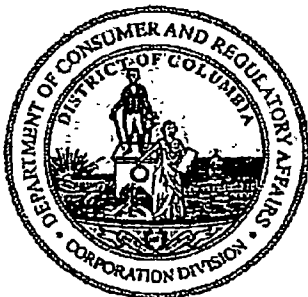



**AMENDED AND RESTATED**  
**ARTICLES OF INCORPORATION OF**  
**THE NEW RIVER EDUCATION FUND**

To: Department of Consumer and Regulatory Affairs

Pursuant to the provisions of the District of Columbia Non-Profit Corporation Act, the undersigned adopts the following Amended and Restated Articles of Incorporation:

**FIRST:** The name of the corporation is:

**REAL CLEAR FOUNDATION**

**SECOND:** The period of its duration is perpetual.

**THIRD:** The specific and primary purposes for which this corporation is formed and for which it shall be exclusively administered and operated are to receive, administer for and expend funds in connection with the following charitable and educational purposes, and to support in other ways the following activities within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986:

1. To promote responsible journalism;
2. To promote think tanks made up of writers and other participants with the interest of educating the public;
3. To assist other charitable, educational, and social welfare organizations in the conduct of similar activities;
4. To engage in other charitable, educational, and social welfare activities as determined by the Board of Directors;

**FOURTH:** The Real Clear Foundation shall not have members.


**FIFTH:** The Directors shall be selected as provided in the bylaws.

**SIXTH:** No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons; except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof;

**SEVENTH:** The private property of the incorporator, directors, and officers shall not be subject to the payment of corporate debts to any extent whatsoever.

**EIGHTH:** Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively for religious, charitable or educational purposes or to organizations which are then exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended and to which contributions are then deductible under Section 170(c)(2) of such Code.

**NINTH:** The address, including the street and number of its initial registered office is 1747 Pennsylvania Avenue, NW, Suite 1000, Washington, DC 20006. The registered agent in charge, located at the registered office stated, is Alan P. Dye.

**TENTH:** The corporation reserves the right to amend, change or repeal any provision contained in this Certificate of Incorporation or to merge or consolidate this corporation with any other nonprofit corporation in the manner now or hereafter prescribed by statute, provided, however, that any such action shall be calculated exclusively to carry out the objects and purposes for which the corporation is formed, and all rights herein conferred or granted shall be subject to this reservation.

**ELEVENTH:** The number of directors constituting the initial Board of Directors is three (3), but the number of directors may be increased or decreased in the manner set forth in the bylaws, provided that the number shall not be less than three (3).
