RISK ASSESSMENT FOR THE 21ST CENTURY (RISK21) TECHNICAL COMMITTEE THE MISSION OF THE RISK21 COMMITTEE IS TO PROVIDE A FORUM THROUGH WHICH SCIENTISTS FROM A VARIETY OF INDUSTRIES, GOVERNMENT, ACADEMIA, AND OTHER STAKEHOLDER GROUPS CAN STIMULATE A DIALOGUE TO IDENTIFY KEY ADVANCEMENTS IN RISK ASSESSMENT TO DESIGN BETTER METHODS TO EVALUATE POTENTIAL HUMAN HEALTH RISKS. THE COMMITTEE'S WORK WAS PRESENTED THROUGHOUT THE YEAR AT SCIENTIFIC MEETINGS IN NORTH AMERICA AND EUROPE.
