

FOURTH: The Corporation is organized and will be operated exclusively for charitable and educational purposes under §501(c)(3) of the Internal Revenue Code (“IRC”). To this end, the Corporation shall maintain a fund for making charitable gifts and contributions for the advancement of the physical, mental, intellectual and spiritual welfare and development of humanity, including gifts for the prevention and relief of disease and poverty, but not excluding gifts and contributions in other forms of charity.

FIFTH: The manner in which directors shall be elected or appointed shall be provided in the bylaws.

SIXTH: No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the Corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of the Corporation shall be limited to reasonable amounts.

SEVENTH: No part of the activities of this Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation to an extent that would disqualify it for tax exemption under IRC §501(c)(3), and this Corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, or any bylaws adopted thereunder, this Corporation shall

not take any action not permitted by the laws which then apply to this Corporation. All references to sections in these Articles shall refer to sections of the Internal Revenue Code of 1986 or to similar sections of subsequent United States Revenue laws.

EIGHTH: Upon dissolution of the Corporation, its assets shall be disposed of exclusively for the purpose of the Corporation or distributed to such organizations organized and operated exclusively for charitable and educational purposes as shall, at the time, qualify as exempt organizations under IRC §501(c)(3).

NINTH: The registered agent is Mary Lou Soller, a member of the Corporation's Board of Directors, and the address, including street and number, of the registered office is 655 15<sup>th</sup> Street, N.W., Suite 900, Washington, D.C. 20005.

SECOND: The restated articles consolidate all amendments into a single record.

THIRD: The text of the amended and restated Articles of Incorporation is attached hereto.

FOURTH: The restated articles were approved by the Board of Directors on November 26, 2013, there being no members having voting rights in respect thereof.

**BY-LAWS  
OF  
THE MILLER & CHEVALIER CHARITABLE FOUNDATION**

**ARTICLE I - DIRECTORS**

The management and all powers of the Foundation shall be vested in and exercised by its Board of Directors which shall consist of such number of persons, not fewer than three and not more than nine, as may be determined by the Board. Except as otherwise determined by unanimous consent of the Directors, the Directors shall be elected by the Directors at the annual meeting of the Directors for a term of one year or until their successors have been elected.

Directors may select one or more Directors Emeritus, who shall have no vote, but may attend meetings.

**ARTICLE II - MEETINGS**

Section 1. The annual meeting of the Directors shall be held on the Tuesday of each year immediately preceding Thanksgiving day at the office of Miller & Chevalier Chartered, or at such time and place as the Directors determine.

Section 2. Special meetings may be called by the President, and shall be called by the President upon the written or electronic request of more than one-third of the Directors. A special meeting may be held telephonically by conference call.

Section 3. At least ten days' notice in writing shall be given to each Director of the annual meeting of the Directors, and at least ten days' notice in writing shall be given of

any special meeting of the Directors. Notice of any meeting may be waived by a Director, and the Director's presence at, or participation in, the meeting shall constitute a waiver.

Section 4. A majority of the Directors shall constitute a quorum at all meetings of the Board of Directors.

Section 5. Any action required or permitted to be taken by the Board may be taken without a meeting if all of the members of the Board consent in writing to the specific action. A writing includes any form of information inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form. Written consents shall be included in the minutes or filed with the corporate records reflecting the actions taken. Action taken under this section is effective when the last Director signs the consent, unless the consent specifies an earlier or later effective date. A consent signed under this section has the effect of a meeting vote and may be described as such in any document.

### **ARTICLE III - POWERS**

The Foundation shall have power to take and hold, by bequest, devise, gift or purchase, either absolutely or in trust, for any of its purposes authorized by its Certificate of Incorporation, any property, real or personal, without limitation as to amount or value, except such as may be imposed by law; to convey such property, to receive income thereon, to invest, reinvest, deal with and expend or disburse the same, whether principal or income, in such manner as the Board of Directors shall approve, for the promotion of the objects for which the Foundation is organized.

## **ARTICLE IV - OFFICERS**

Section 1. The officers of the Foundation shall be the President, the Vice President, the Secretary and the Treasurer and such other officers as may be elected from time to time by the Board of Directors. The same person may be elected Secretary and Treasurer. In addition, the same person may be elected Vice President and Treasurer.

Section 2. At each annual meeting of the Board of Directors, or in default of election at such meeting, then at any subsequent special meeting called for that purpose, the Directors shall elect the officers for the following year. An officer duly elected shall hold office for one year, or until his or her successor is elected and accepts the office.

Section 3. The President shall preside at all meetings of the Directors at which he or she shall be present. He or she shall appoint all committees, and shall be ex-officio a member of all committees, unless otherwise provided in the establishment or appointment of any committee. He or she shall have power to sign in the name of and for the Foundation all deeds, bonds, contracts, agreements, formal instruments and other obligations. He or she shall keep the Directors advised and fully informed as to, and freely consult with them concerning, the business of the Foundation. He or she shall also have, exercise and perform all other powers and duties as may be assigned to him from time to time by the Board of Directors.

In the case of the absence, disability, or failure of the President to act, the Vice President shall exercise the powers and perform the duties of the President.

In the absence or disability of both the President and the Vice President, the President may by written instrument, with the consent of the Board, appoint one or more members of the Foundation to discharge such of his or her functions as he or she may assign to such member or members.

Section 4. Subject to such regulations as may from time to time be prescribed by the Board of Directors, the Treasurer shall have the custody of the funds and securities of the Foundation, including all bonds, deeds and other papers and documents relating to such property, and shall also have charge of the accounts and records. With the consent of the Board of Directors, he may employ a bank, trust company and/or professional manager to keep and/or manage the funds and other properties of the Foundation. Any money in his or her custody shall be separately kept in a bank account in the name of the Foundation, in such bank or banks as the Board of Directors may by resolution direct. All disbursements shall be made by check signed by two officers or Directors.

Section 5. The Secretary shall keep the minutes of all meetings of the Board of Directors and all actions taken without a meeting in books provided for the purpose. The minutes for the annual meeting shall include the names of the recipients of contributions from the Foundation for that calendar year and the amount of each contribution. The Secretary shall attend to the giving and serving of all notices of the Foundation, and shall have charge of such books and papers as the Board of Directors or the President may direct, all of which shall, at all reasonable times, be open to the examination of the officers or Directors of the Foundation: he or she shall in general perform all the duties incident to the office of Secretary, subject to the control of the Board of Directors and the President. The Secretary shall preserve the reports of the Treasurer.

## **ARTICLE V - ADVISORS**

The Board of Directors may consult with one or more advisors not connected with the Foundation, having special experience with charitable giving, and may pay reasonable compensation, if necessary, for such services.

## **ARTICLE VI - COMMITTEES**

The Board of Directors by resolution shall provide for committees to evaluate requests for grants and make recommendations to the Directors regarding appropriate grant recipients. The Board of Directors by resolution may provide for other committees and may delegate to the committees the appropriate powers. Those committees which exercise the authority of the Board (“Board committees”) shall consist only of Directors and include at least two (2) individuals. The creation and appointment of Directors to Board committees shall be approved by the affirmative vote of a majority of all Directors in office when the action is taken. Other committees which do not exercise the authority of the Board shall serve in an advisory capacity and unless otherwise provided in the resolution creating the committee, the appointment of Directors to serve on such other committees shall be made by the President.

## **ARTICLE VII - AMENDMENTS**

The Board of Directors shall have power to alter or amend the By-Laws of The Miller & Chevalier Charitable Foundation, by a vote of two-thirds of all the Directors, at any annual or special meeting of the Board, provided that written notice has been sent to each Director at least ten days in advance of the date of the meeting, stating specifically the proposed

change or amendment; or, without any such notice, then by a unanimous vote of all the Directors

### **ARTICLE VIII - GRANTS**

The Board shall generally consider requests for grants only at the annual meeting. Requests shall be screened by such committees as designated by the Board, which committees shall report in writing to the Board their recommendations of grant recipients. Grant recipients and amounts shall be decided by the vote of a majority of Directors present at the annual meeting.

The Foundation's officers are empowered to approve grants during the course of the year not exceeding in total an amount equal to 10% of the prior year's grants, whether such grants are referred to the Foundation or solicited directly, subject to the normal Foundation grant making guidelines and standards and a relatively high standard of urgency. Any grants made under this procedure are not charged against any particular committee.

A commitment to make a grant extending beyond the current year (i.e. a pledge) shall be made only in extraordinary circumstances and only upon the affirmative vote of two-thirds of all the Directors.

### **ARTICLE IX - LIQUIDATION**

The Foundation can be dissolved at any time by a vote of two-thirds of all the Directors.

In the event the firm of Miller & Chevalier Chartered, ceases to exist, either because it has been dissolved or because it has lost its identity by being merged into another firm, the Foundation shall be dissolved.

Any funds or other property owned or held by the Foundation at dissolution shall be disbursed as determined by a majority of the Directors solely to corporations, trusts or funds organized and operated exclusively for charitable, educational, religious or scientific purposes, no part of the net earnings of which inures to the benefit of any member, private shareholder or individual.
