GOVERNMENT'S POSITION: 5480 is operating as a title holding company exempt under IRC 501(c)(2). It does not provide any social activities for its parent or any other organization. Its income is from rental of the facility to the public and its parent; rental income is allowed under 501(c)(2). Other income is investment income, also allowed under 501(c)(2).

Traditionally, investment in stocks and bonds is an allowable source of income under IRC 501(c)(2). It is not proscribed by the regulations and is not prohibited by the restrictions on "business" income (as a primary source of income). Clearly, an organization exempt under IRC 501(c)(2) may invest in stocks and bonds and passively collect the income from these investments. However, permissible investment activities should be distinguished from the active "business" of securities trading.

Control over the 5480 Club is vested in the officers of the Knights of Columbus Chapter 5480 since the K of C appoints the officers of the 5480 Club.

CONCLUSION: 5480 subsection should be reclassified from IRC 501(c)(7) to 501(c)(2) effective the first day of the period of the audit January 1 2006.
