WACIF's Entrepreneurial Training courses develop a strong foundation to launch a successful small business with topics on business planning, marketing, financial statements, law, real estate and becoming lender ready. WACIF's impact is deepened with one-on-one business counseling which works with clients on specific capacity building issues and identifies areas of growth.

WACIF has several loan funds to support a continuum of financing from start-up entrepreneurs to established business owners that are unable to access traditional financing.
