The Green Olive Tree is a thrift store. The community donates their items they no more care to have in their homes. These items include small household items, clothes, shoes, sports equipment, bed linens, dishes, etc. The items are sorted and put a price to them. The shop has hours six days a week from 11-4 for the community to come and shop for these items at a reduced price.

The Green Olive Tree has been listed as "the best buy" in Albemarle County. One week a month, the shop has bag sale. Occasionally, there are specials on certain items to move out of the shop our overload.

Last year, Equipping the Saints took to their warehouse 52,236 pounds where the year before they took 39,810 pounds to be given to mission. We also gave to Purple Heart, Salvation Army, and GoodWill. Our goal is to recycle our items as much as possible. Yes, there are items that have to be trashed.

We sell our gently used sports equipment to a sports store in town since they can receive a higher return on the merchandise than we can.

We gave 35 families the opportunity to receive free bags of merchandise from our store upon approval of Social Services and special needs. These families received 171 well-stuffed bags. Last year 30/105.

Books are given to Friends of the Library for sell to help the library system. These books were either not the quality for a Christian thrift store or they were more valuable than what we could receive in our shop. 160 BOXES were donated which made well over 1,600 books. Over 500 Harlequin Romance books were donated.

\$4,411.70 approximately by our pricing were donated to local churches, school, school groups, mission trips, and people in need.

Our reserves are blessed to help us prepare for the need for relocation.

We feel blessed in our success as a business that has been in operation over 30 years and it started as a simple business and has been divinely blessed and the good we are trying to do.

We have become an important business to the community of Crozet.

We help the drama club at the high school, we provide materials for handicap children.

Our entire staff is volunteer folks believing in this mission.
