Both Kids R First programs are based to help students who receive Free or Reduced Priced Meals in the public schools in Northern Virginia.

School Supplies Program - Students' names are confidential and only known by counselors and other staff at each school served. The number of students vary by the total in need per school community. Counselors fill out our form which identifies the school supplies that will be needed when students return to school each fall (August or September). We custom order for each school so students receive exactly what they will need for their required classes and by subject.

College and Career Bound Fund - for students (grades 9-12) at 18 high schools in Northern Virginia.

This fund, allocated through the guidance department of each participating school, provides economically disadvantaged students the opportunity to participate in an academic or extra activity that requires a fee. Students, identified with potential and motivation to succeed, are provided with a mini-scholarship which may cost between \$25-\$150. (Average fee - \$40).

Any amount higher than \$200 requires approval from the CCB Chair person. The program criteria and uses of funds have been approved by the KRF Board of Directors.

Due to student privacy rights, names are not revealed. Reports are sent to the CCB Chair of the organization identifying the funding uses and the numbers of students helped at each

school. Students do not receive funds, but fees are paid through the "finance department" of each school. This program receives "HUGE" accolades!
