In Spring 2013, ART 180 offered community programs in partnership with Communities In Schools of Richmond at the following schools. Boushail Middle School where each young artist designed and constructed a variety of fashion accessories showcasing their individual style and sense of self. They were presented in a runway show. Charterhouse School, participants wrote and performed a song, featuring drums and voice, that reflects on the school's guiding concepts of belonging, independence, mastery and generosity. Communities In Schools of Richmond - Elkhart Middle School Participants explored how they feel about Richmond and what is meaningful to them in their community Their answers are contained in the 4-ft letters of a painted "Richmond" sign and a series of postcards showing the artists with their letters in front of various Richmond backdrops. Franklin Military Academy "Choose your path" was the theme of the tile mosaic mural created by these young artists, who worked together to develop a design illustrating the different possibilities that life offers and the decisions young people need to make in order to reach their dreams. The mural, constructed of more than 900 pieces of tile, will be installed in the cafeteria at Franklin Henderson

Description

Middle School, participants made paintings based on their dreams and nightmares, delving into what those dreams might mean, and inspire, through personally meaningful color and imagery. Oak Grove Elementary School, collaborative writing and drawing exercises formed the foundation of an interlocking group painting, exploring the diversity within a community of individuals. The final piece, "Drawn Together," represents the participants' sense of connectedness and respect for each other. Thompson Middle School, participants learned to make video games, each with a unique concept symbolizing a challenge to overcome or goal to achieve. Other programs of note were Richmond Behavioral Health Authority (RBHA). Participants made curio cabinets filled with an assortment of hand-made objects reflecting their identity, their history, and what captures their interest now and as they imagine their futures. The Salvation Army Boys and Girls Club, participants created a mural, "Art and Music," that complements the mural created on-site in 2011 and commemorates ART 180's very first project at the club 15 years ago. William Byrd Community House Young artists created paper maché sculptures of personal animal totems, which represent aspects of themselves they want to cultivate to fully become the people they want to be. Richmond Organization for Sexual Minority Youth (ROSMY) Drawing, writing, sculpture and mixed media projects gave participants further opportunities to explore issues related to identity, relationships and health addressed in ROSMY support groups. The artwork created over an eight-month period was collected in a book called Every Rainbow Thing I Can Find and presented in an exhibition at the Gay Community Center of Richmond. Impact to the community through programs for 2013 were 374 young people served and 103,911 people were exposed to ART 180 through exhibitions, workshops, performances, book launch and annual showcases.
