Girls Write Now is New York's first and only organization with a writing and mentoring model for girls. We are a community of professional writers dedicated to providing opportunities for underserved high school girls to develop their independent voices and write their way to a better future. Our girls are 90% high need, 90% girls of color, and 20% immigrant. For 16 years, our program has broken through the barriers of gender, race, and poverty, transforming the lives of nearly 5,000 girls, and sending 100% of our seniors on to college with portfolios, scholarships, and a new sense of confidence. Girls Write Now's flagship program is our Writing & Mentoring Program, which began in 1998, girls hone the craft of writing by working one-to-one with their mentors as they build portfolios of work. This program advances the skills of young writers by presenting genre workshops, hosting readings, and publishing an award-winning anthology all in an effort to aid the girls on their journey to become writers who can one day break through the glass ceiling in the media and publishing world. In response to the increasingly digital nature of the writing and media landscape, Girls Write Now created a Digital Media Mentoring Program in 2012, which was brought to scale in Fall 2013. The digital program teaches new technologies and digital platforms to elevate girls writing online. Finally, the College Bound Program is designed for both girls in our mentoring programs, as well as girls in the larger New York City community that stand to benefit from college informational seminars, essay-writing workshops, panels with guest speakers who offer insight on college life, and informational sessions about the financial aid process. Girls Write Now has been distinguished by the President's Committee on the Arts and the Humanities as one of the nation's top after school programs. Our girls have won hundreds of Scholastic Art & Writing Awards. In 2013, our girls won 40 competitive Scholastic Art & Writing Awards, and 44 percent of our seniors earned college scholarships.
