THE FUNDRAISER COMPRISED A COMMUNITY DINNER WITH RAFFLES, LIVE AND SILENT AUCTIONS, AND A MUSIC CONCERT. WITH MINOR EXCEPTIONS, ALL OF THE DIRECT EXPENSES OF HOLDING THE BENEFIT WERE DONATED BY BENEFACTORS. BECAUSE THE EVENT, INCLUDING FOOD, PREPARATION, AUCTION ITEMS, AND PERFORMERS WAS UNDERTAKEN AT MINIMAL COST TO THE ASSOCIATION, THE PROCEEDS OF TICKET SALES AND AUCTION PROCEEDS HAVE BEEN CONSIDERED CONTRIBUTIONS. THE PROCEEDS OF THE BENEFIT ARE DONATED TO THE INDIVIDUAL TO FUND HER MEDICAL EXPENSES.
