HSLC is an animal welfare organization serving the residents of Loudoun County, VA since 1966 with the mission of creating a no-kill community (save a minimum of 90% of the animals entering the county shelter). This is accomplished by implementing a comprehensive strategy which includes low cost spay-neuter, foster care, adoption, TNR, lost & found, medical treatment, community involvement, and rescue partnerships.

Spay/Neuter Program: HSLC provides a discount voucher program for Loudoun residents who might not otherwise have the information or resources needed to spay/neuter pets in the community. In 2013, HSLC facilitated the spay/neuter of 656 animals under the following programs: Discount Green Sheet Certificates, Pit Fix, Foster S/N and Community Financial Assistance, significantly reducing the homeless pet population in our county. It is estimated that one unaltered cat can produce up to 130 kittens over a three year period. These programs provide low cost spay/neuter services for cats, dogs, Pit breeds, and pet rabbits.

4b (Code:) (Expenses \$ **51,234** including grants of \$ **4,250**) (Revenue \$ **11,371**)
Foster/Adoption: HSLC provides temporary housing, quality medical care, and facilitates the permanent placement of abandoned and abused animals in the county. In 2013, HSLC assumed new responsibility for 125 animals, including 52 cats which were transferred out of the tax payer funded county shelter. Several of the animals have special needs due to abuse or lack of adequate medical care. By year end 2013, 116 animals had been placed in permanent homes.

4c (Code:) (Expenses \$ **28,828** including grants of \$ **15,500**) (Revenue \$ **7,490**)
Feral Cat Program: Performs the critical task of Trap-Neuter-Release (TNR) for feral cat colonies in the area. TNR is a proven method for improving the health and decreasing the population of cats living outdoors under the supervision of experienced caretakers. By providing vaccinations, medical treatment, and preventing overcrowding, the TNR program ensures a safe environment for both animals and humans. In 2013, HSLC provided TNR for 449 community cats potentially preventing the reproduction of thousands of homeless and unvaccinated kittens.
