CommunityWorks in West Virginia, Inc. has recognized the need to attract young leaders with formal training at the graduate level to the affordable housing industry since many of the current leaders within local housing agencies and organizations are approaching retirement age and young talent is needed to address the challenges related to community development and innovative housing solutions throughout West Virginia. Attracting young graduates to the affordable housing industry is essential if the industry is to continue to move forward in future years.

In order to address these needs, CommunityWorks in West Virginia has provided twelve week internships for graduate students for the past four years. The program has provided internship placements for 38 graduate level students through a partnership with graduate schools at higher education institutions in West Virginia (primarily West Virginia University, Marshall University, and West Virginia Wesleyan). The CWWV Internship program has been highly valued by both graduate level students who have participated and sponsoring organizations that have benefitted from the program. Volunteer Program CommunityWorks in West Virginia, a statewide intermediary of nonprofit organizations provided support for local, volunteer-based housing organizations in their efforts to assist low income and elderly homeowners with needed repairs and rehabilitation of their homes during the past year. The attendees heard from panel members who were participating in the different programs sponsored by CommunityWorks such as their Community Design Innovations program, their Volunteer Based Programs and their Affordable Housing Internship Program which provides graduate level emerging leaders from West Virginia University and Marshall University the opportunity to work with different nonprofits in order to gain knowledge of the affordable housing industry.
