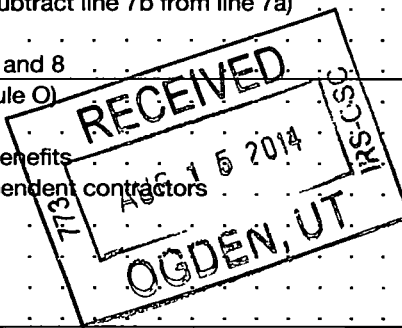

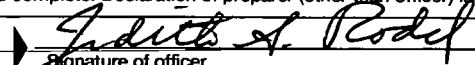

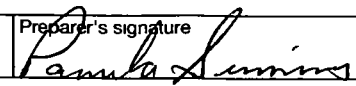

Friends of Blackwater 2013 Projects

Blackwater Canyon and Trail Protection: Friends of Blackwater continues to work to protect the federally owned Blackwater Canyon Rail Trail. We distributed trail maps and have them on our website. We are pressuring the Forest Service to put up more interpretive signage along the Rail Trail and are doing research on the historic railroad community of Lime Rock for future signage and historical interpretation along the Rail Trail. We designed and printed a brochure on the coal and coke industry of historic Coketon along the Trail which we hand out at our Davis, WV Office. We are working with the Allegheny Trail group to move their West Virginia north/ south hiking trail onto the Rail Trail at Douglas. **Expenses - \$48,775.03**

Save Our Squirrel (SOS): While the rare West Virginia northern flying squirrel is no longer official protected on private land it is still protected on the federal Monongahela National Forest. "Ginny" the flying squirrel is the most unique mammal of the Allegheny Highlands and the signature species of Blackwater Canyon. We are working with the Monongahela National Forest to insure that the squirrel's protections continues on this federal land. In 2013 we formed a partnership with Purdue University to study the diet of the West Virginia northern flying squirrel using hair samples to analyze foods eaten and understand population through DNA analysis. Hair snare traps were set out on grids in Blackwater Falls State Park and the Monongahela National Forest. Hair will be analyzed over the next two years. We continue to advocate for rare bats threatened by white-nose syndrome and for bald and golden eagles. **Expenses - \$6,046.28**

North Fork Watershed Project (NFWP): The North Fork of the Blackwater River flows along the Blackwater Canyon Rail Trail and is negatively impacted by acid mine drainage pollution from old underground mines. Our employees monitor water quality in the North Fork with volunteer help once a month. We organized a meeting of experts and stakeholders to discuss plans for remediation of the North Fork's AMD pollution and supported the work of the WV Department of Environmental Protection in reclaiming strip mines in the watershed. We continue to monitor headwater streams that flow through Blackwater Falls State Park and also Beaver Creek to analyze their potential for remediation and native brook trout reintroduction. We reported heavy sedimentation into Beaver Creek in the summer due to road construction and had it stopped. We also worked with the Three River Quest program to monitor conductivity through the watershed. The project hosted a team of ten young people from the National Civilian Community Corps who did maintenance work on the trails we had created in Thomas City Park. **Expenses - \$28,488.47**

The J.R. Clifford Project:

JR Clifford Project educates citizens about West Virginia's first African-American lawyer, who fought in the Civil War, was a newspaper publisher and a co-founder of the Niagara Movement, the predecessor of the NAACP. He brought a successful civil right case from Coketon in Blackwater Canyon in 1896. To honor the State's 150 birthday, we created and put on a living history drama: "A New Home for Liberty, Human Rights, Slavery and the Creation of West Virginia" featuring Clifford and the state's abolitionists. The play was put on in 2013 in Elkins at the old courthouse and in Wheeling at West Virginia's first capitol, Independence Hall. We created a New Home for Liberty poster to give out at events. Two historic markers were put up in Tucker County to honor JR Clifford's famous civil rights case, one at the Courthouse and one near the location of the Coketon "colored" school. **Expenses - \$21,836.38**

MON PLAN: Protecting the Monongahela National Forest in West Virginia's High Allegheny Mountains

Friends of Blackwater continued the dialogue on fracking through the Eastern National Forests Gas Drilling Working Group working with national forest advocacy groups in seven states to review and object to problematic gas drilling proposals on these public lands. We collaborated on an educational website on fracking on public lands particularly eastern national forests. We also reviewed and commented on timber proposals that could impact endangered and rare species on the Mon. **Expenses - \$7,498.26**

Allegheny Highlands Climate Change Initiative

We began planning for the AHCCI conference for June of 2014 to feature speakers on the impacts and risks to the Allegheny Highlands from climate change. We are working with a number of scientists we have been in contact with through our work to protect Blackwater Canyon and the Monongahela National Forest. We formed a working group to plan the agenda, created a climate change library, rented conference space and announced the conference in our newsletter. Staff attended trainings. We created a budget and a fundraising plan.

Expenses - \$7,869.49
