Food can either be obtained at the pantry or for some we deliver. 7 days a week we collect food and at specified times during the week people either come to receive it or we deliver it to them. The number of people that receive food each week is approximately 1500, and we use approximately 75 volunteers to accomplish this.

Restoration Bridge International holds support group meetings two times a week for those in recovery from addictions, grief, etc., and also those that want to improve their lives. We maintain approximately 6 groups with 12 facilitators and approximately 50 people attend.

Restoration Bridge International holds weekly support meetings for men and student athletes. We also pay partial therapy fees for needy injured student athletes. The number of students we helped this year is 22.
