The net operating loss carryforwards begin to expire in 2025 for federal purposes and 2020 for state purposes. NCAR's wholly-owned subsidiary is subject to federal and state corporate income taxes. At December 31, 2013, NCAR Service Corporation had no federal tax liability.

An attempt to obtain information necessary for filing an accurate and complete return was requested in a timely fashion, but the information was not furnished in sufficient time to permit a timely filing of the return.
