In 2010 the Society received substantially less than expected on its beneficial interest in two of the CRUTS. The Society was informed this occurred because (1) the liquidation order of the CRUT gave priority status to another not-for-profit organization, and (2) the recession negatively impacted the overall value of the two CRUTS. In response to this unexpected result and in anticipation of not receiving anything on the remaining CRUTS, the Society made the decision to write off its beneficial interest in the remaining two CRUTS. Permanently restricted net assets for endowment totaled \$20,000 which are intended to support the Society to develop, encourage, and promote public awareness of and appreciation for North Carolina's coastal natural and cultural heritage, to serve as a philanthropic society for the support, maintenance of programs, and development of facilities of the North Carolina aquariums, and to solicit, hold, invest, and expend funds for such purposes, and to render assistance as requested by the North Carolina aquariums.
