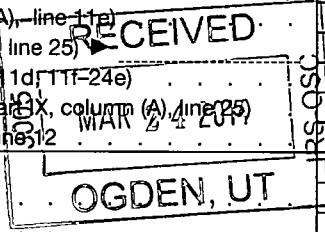

The mission of the North Carolina Holocaust Foundation is threefold: (1) to educate North Carolinians on the historical importance and lessons learned from the Holocaust, (2) to remember and commemorate those individuals who perished due to planned and systematic Nazi persecution, and (3) to reflect upon genocidal events happening around the world today and to call for action.

4a (Code: WRKSHP) (Expenses \$ \$13,212.98 including grants of \$ _____) (Revenue \$ _____)
The Teacher Workshops consist of North Carolina public school teachers meeting with (1) a university professor to learn about European anti-Semitism and the events leading to the 1932 election of the Nazi Party, (2) a former public school teacher to learn how to teach the Holocaust to middle school and high school students, and (3) a Holocaust survivor to hear a first-hand account and experience of suffering and surviving the Holocaust. The overall themes of the workshops are (1) to explain why the teaching of the Holocaust is relevant and important and (2) to provide teachers with the skills and methods to teach students how to understand the lives and circumstances of others, and how to empathize and appreciate, rather than fear, differences among people.
The \$13,212.98 include (1) hotel, honorarium, travel (gas mileage reimbursement), and food expenses for the speakers and (2) the copy expense for teacher handouts. The Foundation conducted a total of nine (9) workshops in the spring of 2013 and the fall of 2013.

4b (Code: EXHBTS) (Expenses \$ \$11,245.70 including grants of \$ _____) (Revenue \$ _____)
The Traveling Exhibits consist of Holocaust exhibits that travel throughout the state. There are eight exhibits: four (4) "Dr. Seuss Goes to War" exhibits, two (2) "Kindertransport" exhibits, one (1) "Triumph of Will" exhibit, and (1) "Butterflies, Fences and Walls" exhibit. These exhibits are displayed in schools, libraries, and community centers. Recommended lesson plans, books, and DVDs accompany the exhibits. Many times a Holocaust survivor speaks at a school around the same time the exhibit is there.
The \$11,245.70 include (1) the travel (gas reimbursement) for the person transporting the exhibit, (2) an honorarium for three individuals who coordinated, scheduled, and drove the exhibits, and (3) costs to repair the exhibits. In addition, and included in the expenses, the Foundation purchased three Dr. Seuss exhibits in calendar year 2013.

4c (Code: THEATRE) (Expenses \$ \$5,600.00 including grants of \$ _____) (Revenue \$ _____)
The Touring Theatre of North Carolina performs the Holocaust play, "Let Your Children Tell." The play, which lasts approximately 100 minutes and has a cast of five players, depicts the actual lives of five middle school-aged children who suffered in the Holocaust. Some of the children survived the Holocaust while others were murdered. The play is shown at middle schools and high schools in North Carolina.
The expenses include gas mileage, hotel and food per diem, and an honorarium for each actor. The Foundation does not break-out the \$5,600.00; expenses are paid by the Foundation to the Touring Theatre of North Carolina in a lump sum.
